1. Should have duly registered with the Registrar-General's Department and have published at least three titles.
2. Complete the attached Membership Form
3. Submit a copy of your registered documents. Company – Certificate of Incorporation, Certificate to Commence Business, Form “3” and Company Constitution or Regulations. Sole proprietorship – Form A and Certificate of Registration and Partnership requires Form “A” and Certificates of Registration.
4. Submit two copies of each of all your published titles.
5. Submit a copy of your Curriculum Vitae
6. Submit a copy of your accreditation as the representative of a foreign publisher in Ghana.
7. Application should be recommended by two (2) GPA members.
8. APPLICATION FEE: GH¢1,000.00 (paid before assessment and is non-refundable)
9. DUES PER ANNUM: To be determined after application (paid after approval of membership)
